- 1. Shareholders must enclose the following documents relating to the form.
 - 1.1 The evidence of shares held, such as the certificate of shares held from the Securities Company or any other certifications from the Thailand Securities Depository Co., Ltd. (TSD)
 - 1.2 If shareholders are juristic persons, the copy of the company's affidavit, the latest updated no later than 3 months, and a copy of the identification card/passport, in case of non-Thai nationality, of the authorized director must be enclosed and certified as true copies by such director.
 - 1.3 If shareholders are individuals, a copy of the identification card/passport (in case of non-Thai nationality) must be enclosed and certified as true copies by the shareholder.
- 2. The shareholders must submit the Board 1) the Director Nomination Form and 2) the Information Form of Candidate Proposed for Directorship. The shareholders can send the proposal unofficially via facsimile at 02-318-3963 or the Corporate Secretary's email address at comsec@tcm-corporation.com and send the original within 1st February 2024 for Board considerations, based on the Company's criteria and propose to AGM.
- 3. In case many shareholders have unified to propose the candidate for directorship, those shareholders must prepare the forms to submit to the Boards as follows.
 - The first shareholder must complete the Director Nomination Form and sign the form for evidence. The second shareholders and onwards complete only Part A of the Form to Propose the Candidate for Directorship, and all shareholders sign the forms for evidence. All forms, evidence of shares held, and all additional documents (if any) of all shareholders and documents for consideration, which are identified in the forms, must be packed into one set.
 - The shareholder must arrange a candidate proposed for directorship, complete the Information Form of Candidate for Directorship with the candidate's signature, and provide the documents for consideration, as specified in the form.
- 4. If more than one shareholder proposes more than one candidate for directorship to the Board, shareholders must complete the Director Nomination Form and the Information Form of Candidate Proposed for Directorship separately, as one set for one candidate.
- 5. If shareholders have their title, name, or surname changed, the copy of evidence of those changes must be enclosed and certified as a true copy.
- 6. Additional supporting documents that will be useful for the Board's consideration (If any).
